

POLICY SECTION 4000 - COMMUNITY RELATIONS

INGERSOLL STADIUM SAFETY & SECURITY MEASURES

To ensure the security of the facility while maintaining a safe environment for district and community users the following measures will be in place.

USE

- 1) User groups are limited to those specifically listed in the 2004 City of Olympia Hearing Examiners Decision and as reaffirmed in April 2013 (Thurston County Youth Football, Youth Soccer Associations, City of Olympia Parks, Arts, and Recreation Track Meets) along with programs and activities conducted/sponsored by the Olympia School District.
- 2) No community use is permitted during school classes, school district and/or approved user group practices, games, or activities without prior consent from the Executive Director of Operations.
- 3) Hours of operation for District and approved non-district user groups shall be consistent with OSD Procedure 4260P(C)
- 4) Hours of use by individual community members shall be 5:00 am to 10:00 pm (see restrictions above #2). There is no access to the facility by community or district users between 10:00 pm and 5:00 am.
- 5) Hours of use may be modified. If modifications are made, the community will be notified via the District website and/or postings at the community entrance gate.
- 6) There shall be no commercial use of the facility by trainers or others charging a fee for services.

FIELD & TRACK USE

- 1) Only shoes approved for use on turf and/or all-weather track surfaces may be used.
- 2) Jogging is limited to lanes 6 – 8
- 3) No food, gum, seeds, shells, sports drinks, or glass containers are allowed on the track or field surfaces. Only water in plastic containers in acceptable.
- 4) Parking or any use of a vehicle (including bicycles, skateboards, scooters, skates, etc.) is not allowed inside the fenced area of the facility.
- 5) Use of the turf field is limited to approved users groups and district activities noted above (use #1).

GRANDSTANDS

- 1) Use of the grandstands is limited to walking/running stairs.
- 2) At no time is running/jumping or doing “sit ups” allowed on seating areas.

SECURITY/ACCESS

- 1) The District has installed security cameras at access gates and in locations to view the field and track. If damage or misuse has been observed or reported, tapes will be reviewed.
- 2) Access by individual community members will be provided through a key card system located at the “south community access gate”.

- 3) The District will control access during established “non-use” hours by locking all access gates.

COMMUNITY ACCESS

- 1) Access cards will be distributed to individual community members wishing to use the facility for personal exercise.
- 2) Key cards will be made available through the Support Service Center Office. Key cards will be provided to those individuals agreeing, in writing, to comply with all rules and regulations for use. Community and student access key-cards may be obtained through the Support Service Center Office.
- 3) A fee of \$10 will be charged to community members for each key card. No fee will be charged to district students with student ID cards. If any key-card is lost an additional fee of \$10 will be charged for a new card.

CONDUCT AND COMPLIANCE

Misconduct, misuse, possession or use of intoxicating beverages and/or controlled substances, the carrying of weapons or other violations of established regulations noted in this procedure, Procedure 4260P(C), and/or the community access agreement, will be sufficient cause for denial and/or termination of access.
