McKinney-Vento Eligibility Definition:

A student is eligible for services if their students current nighttime residence is:

Temporarily living with another person/ family due economic hardship & lack or loss of housing;

In an emergency or domestic violence shelter;

In a residence with inadequate accomodations(no water, heat, electricity etc.);

In a motel or hotel due to lack/loss of housing & economic hardship ;

In Transitional housing program;

In cars, parks, public spaces, abandoned buildings;

Moving from place to place or "couch surfing"; or

Due to being displaced because of fire, natural disaster etc.

The McKinney-Vento Liaison Designee will determine whether a student qualifies for support through self-identification, referral or the OSD Student Housing Questionnaire.

# **McKinney-Vento Act**

The McKinney-Vento Education Act Title X Part C legislation ensures that students experiencing homelessness & houseless have full equal access to a public education. School districts are required to eliminate barriers to public education that prevent homeless or houseless students to enroll, attend and succeed in school.

#### **Rights of McKinney-Vento Eligible Students:**

Immediate school enrollment even if the student lacks health, immunization or school records, proof of guardianship or verification of current nighttime residence

Enroll in the school the student attended when permanently housed; school last attended or the school local to the students current nighttime residence

Attend the students current school for the school year even if they change nighttime residence or obtain permanent housing during the school year they qualified as McKinney- Vento eligible

Receive free breakfast and lunch at school

Receive school transportation to the students school for the duration of the school year in which the student qualified for McKinney -Vento eligible.

Obtain information regarding community services for food, shelter, clothing, healthcare, and after school programs

Participate in tutoring and school-related activities.

Each school district must have a McKinney-Vento liaison. See Olympia School District contact information on the reverse side of this page
